TOURISM (TRAVEL TRADE ENTERPRISE REGISTRATION AND LICENSING) REGULATIONS, 2019

IN exercise of the power conferred on the Minister responsible for Tourism by section 48 of the Tourism Act, 2011 (Act 817) and on the recommendations of the Board, these Regulations are made this 30 day of August, 2019.

Registration and licensing of travel trade enterprise

Registration of travel trade enterprise

1. (1) A person who intends to operate a travel trade enterprise shall register the enterprise with the Authority in accordance with sections 25, 26, 27 and 28 of the Act.

(2) An application for registration of a travel trade enterprise shall be made in writing as set out in Forms One A, B, C, D or E of the First Schedule.

(3) The items for payment specified under item 5 in the mandatory requirements for car rental set out in Form One B is subject to review by the Authority.

(4) The list of mandatory requirements specified under Form One E is subject to review by the Authority.

Licence for travel trade enterprise

2. (1) A person shall not engage in the business of providing services as a travel trade enterprise if that person does not have a licence for that purpose issued by the Authority in accordance with sections 25, 26, 27 and 28 of the Act.

(2) For purposes of subregulation (1), the business of providing a service as a travel trade enterprise does not include acceptance of bookings

- (a) relating to a scheduled or systematic transport service within or outside the country for any person; or
- (b) for reward for a person to lodge in a hotel, motel or other accommodation in the country.

(3) A person who contravenes subregulation (1) commits an offence and is liable on summary conviction to the penalty specified in subsection (2) of section 48 of the Act.

Qualification for licence

- 3. A person qualifies to be licensed as a travel trade enterprise if that person
 - (a) has a business entity registered in the country;
 - (b) is registered by the Authority;

- (c) has a manager registered and licensed by the Authority;
- (d) has an insurance policy to cover the operations;
- (e) has the relevant facilities for the operation of the travel trade enterprise;
- (f) has registered with the Authority, the premises from which that person intends to operate; and
- (g) has not been convicted of a serious offence or an offence that involves fraud or dishonesty.

Application for licence

- 4. (1) The licence shall be obtained by application to the Authority.
 - (2) The application for the licence shall be
 - (a) made in writing as set out in Form Two of the First Schedule; and
 - (b) submitted to the Authority for consideration.
 - (3) The application shall be accompanied with the
 - (i) certificate of business registration;
 - (ii) certificate of incorporation, commencement and company regulations, in the case of a business entity registered as a company;
 - (iii) certificate of registration of car rental drivers in the case of an application to operate a car rental service;
 - (iv) certificate of registration for a tax identification number,
 - (v) certificate of registration of the manager;
 - (vi) certificate of registration of the premises;
 - (vii) certificate of registration with the Authority; and
 - (viii) the prescribed fee.

Grant of licence

5. (1) The Authority may grant or refuse to grant the licence of a travel trade enterprise to an applicant after considering the application of that applicant.

(2) Where the Authority refuses to grant an application, the Authority shall communicate the reason for the refusal to the applicant within fourteen days after the decision.

(3) A person whose application for a licence is refused may lodge a complaint with the Tourism Appeal Panel established under section 33 of the Act which shall within thirty days after receipt of the complaint, take a decision on the complaint.

TOURISM (TRAVEL TRADE ENTERPRISE REGISTRATION AND LICENSING) REGULATIONS, 2019

(4) A person may pursue the matter in court if that person is dissatisfied with the decision of the Tourism Appeal Panel or where the thirty days has expired without a decision being made by the Panel. Non-transferability of licence

6. The provisions on non-transferability of licence as specified under section 28 of the Act apply to these Regulations.

Renewal of licence

7. The provisions on renewal of licence as specified under section 30 of the Act apply to these Regulations.

Suspension of licence

8. (1) The Authority shall suspend the licence of a travel trade enterprise after giving the travel trade enterprise thirty working days written notice, if

- (a) in the opinion of the Authority the holder of the licence does not have a facility required for the proper delivery of the service;
- (b) the Authority receives consistent complaints from patrons of that travel trade enterprise;
- (c) a director of the travel trade enterprise is convicted of an offence that involves fraud or dishonesty; or
- (d) that travel trade enterprise fails to submit returns within the period specified by the Authority.

(2) Where the Authority suspends a licence, the Authority shall require the holder of the licence to remedy the breach that caused the suspension within the period specified in the notice of suspension.

(3) Where the Authority is satisfied that the holder of the licence has remedied the breach, the Authority shall restore the licence, otherwise the licence shall be revoked.

Cancellation of licence

9. (1) The Authority shall cancel the licence of a travel trade enterprise, after giving ninety days written notice if

- (a) a person who holds majority shares in the travel trade enterprise is convicted in the country or elsewhere, of an offence involving fraud or dishonesty;
- (b) the travel trade enterprise becomes insolvent or goes into liquidation; or

(c) in the opinion of the Authority, the licence was obtained by fraud or misrepresentation or non-disclosure of any fact. material

(2) The Authority shall consider a representation or objection made by the travel trade enterprise before the cancellation is made. Registration and licensing of manager

- **10.** (1) A person shall not be engaged as a manager of a travel trade enterprise unless that person is registered in accordance with section 29 of the Act and is licensed under these Regulations.
 - (2) A person registered as a manager qualifies to be licensed by the Authority if
 - (a) the person holds a minimum qualification of a Diploma in hospitality management, tourism management or a tourism related subject awarded by an institution recognised by the Authority, or
 - (b) the person has a minimum of five years working experience in the industry and has undergone relevant training determined by the Authority and has obtained a Police Clearance Certificate in respect of the criminal record of that person.

Registration of premises.

11. (1) A person who intends to use premises for a travel trade enterprise shall register the premises in accordance with this regulation.

(2) The premises shall be registered by the Authority where the person provides

- (a) proof of ownership or tenancy;
- (b) a report from the Environmental Health Division of the relevant District Assembly approving of the premises;
- (c) a Police Clearance Certificate in respect of the security of the premises; and
- (d) a Fire Safety Certificate.

Submission of returns

12. (1) A travel trade enterprise shall submit returns to the Authority annually.

(2) The returns shall be submitted in a form as set out in Forms Three A,B,C,D or E of the First Schedule.

Power of inspectors

13. (1) Sections 39, 40 and 41 of the Act relating to inspectors apply to these Regulations.(2) The inspection report of an inspector for a travel trade enterprise shall be made in a form as set out in Forms Four A, B, C or D of the First Schedule.

TOURISM (TRAVEL TRADE ENTERPRISE REGISTRATION AND LICENSING) REGULATIONS, 2019

Complaint on services provided by operator

14. A person who is dissatisfied with the services provided by a travel trade enterprise may lodge a complaint with the Authority in accordance with section 32 of the Act.

Appeals against decisions of the Authority

15. A person who is aggrieved with a decision of the Authority under these Regulations may appeal against that decision in accordance with section 34 of the Act.

Specific provisions relating to charter flights

Advance Booking Charter flights

16. A person who operates a charter flight from the country shall operate the Advance Booking Charter flight. Requirement for licence as tour or travel operator

17. (1) A person shall not organize or operate a tour in this country if that person does not have a licence issued under these Regulations.

(2) An applicant for a licence under subregulation (1) shall, in addition to the information submitted under regulation 4, provide information on

- (a) the proposed routes;
- (b) the proposed date of commencement of the tour;
- (c) the estimated price per tour to be charged to each tourist, inclusive of all services provided; and
- (d) details of any arrangement which the applicant proposes to make for the accommodation and refreshment of the tourists to be carried.

Requirement for licence to operate charter flight

18. (1) A person shall not organize or operate a charter flight on a route specified in the Second Schedule if that person does not have a licence issued under these Regulations.

(2) An application for a licence to operate a charter flight shall be made in writing as set out in Form One of the Third Schedule.

Permit for special charter flights

19. (1) Despite regulations 16 and 17, the Minister may grant a permit to any person or organization to organize a special charter flight on any route other than a route specified in the Second Schedule.

(2) A person who is granted a permit under subregulation (1) shall apply in writing to the Authority for a special licence.

(3) An application under subregulation (2) shall contain

- (i) the name and address of the applicant;
- (ii) the business name of the applicant;
- (iii) the proposed routes;
- (iv) the proposed times and frequency of the flights;
- (v) the proposed date of commencement of the flight;
- (vi) the estimated cost of organizing each flight;
- (vii) the estimated price to be charged to each passenger; and
- (viii) written evidence of a bank guarantee of a sum determined by the Authority to be made available for the purpose of repatriating stranded passengers or reimbursing any person who has paid in whole or in part for a flight in the event that the flight could not take place.

(4) A special licence is valid for the period that the Authority may specify in the licence. Nomination of airline to operate charter flight

20. (1) Where an airline is nominated by the Minister to operate a charter flight, that airline shall obtain from the Authority, a licence to operate the charter flight.

(2) The Authority shall grant a licence to operate a charter flight to an airline nominated under subregulation (1), if the airline satisfies the Authority by written evidence that the airline has secured

(a) a bank guarantee sufficient to repatriate any stranded passenger or reimburse any person who has paid in whole or in part for a valid air ticket for that flight; and an insurance cover for the plane and the passengers.

Sale of seats to tour or travel operator

- **21. (1)** A person who operates a charter flight from this country shall sell the seats on the flight to a tour or travel operator who shall resell the seats to the passengers.
 - (2) A person who operates a charter flight shall not
 - (a) purchase a seat on the flight from the tour or travel operator to whom that person had previously sold the tickets unless that person repurchases from that tour or travel operator all the seats that person had previously sold to the tour or travel operator before the Advance List was submitted to the Authority in accordance with subregulation (3) of regulation 22; and

(b) act as agent for any tour or travel operator for the purpose of reselling seats on the charter flight to any passenger.

Submission of particulars of tour operator to Authority

22. (1) The operator of a charter flight shall, within ninety days to the date of the charter flight, submit to the Authority the names and licence numbers of the tour or travel operators to whom that person has sold seats on the flights, stating in respect of each tour or travel operator, the number of seats sold and the price paid in respect of each seat and the type of aircraft to be used for the flight.

(2) The information to be submitted to the Authority shall be as set out in Form Two of the Third Schedule.

(3) A person who operates a charter flight shall in addition to the information required under subregulation (1) submit to the Authority an Advance List as set out in Form Three of the Third Schedule specifying the flight and giving in respect of each person to whom the tour or travel operator has agreed to resell a seat on the charter flight, the following particulars:

- (a) the personal details of the purchaser of the ticket;
- (b) where the charter flight is an outward journey,
- (ix) the date of intended arrival at the end of the return journey of the passenger; or

(ii) the name of the operator by whom the passenger is to be carried on the return journey or the charter flight number of the return journey of the passenger, where the passenger is to be carried by different operators on the outward and return journeys;

(c) where the charter flight is a return journey;

(i) the date of departure on the outward journey of the passenger; or (ii) the name of the operator of the charter flight by whom the passenger is to be or has been carried on the outward journey or the charter flight number of the outward journey of the passenger, where the passenger is to be carried by different operators on the outward and return journeys; and

(d) the amount to be paid by or on behalf of the passenger for accommodation, car hire or anything additional to the carriage of the passenger by air on the charter flight.

(4) Subject to subregulation (3) and (4) of regulation 26, subregulation (3) does not apply where the operator of the charter flight allocates seats on a charter flight to

- (a) a director or an employee of the tour or travel operator who has purchased seats on the charter flight, whether travelling on business or otherwise, and the immediate family of members or persons travelling with them;
- (b) travel agents, journalists or owners and managers of hotels being used or intended to be used by a tour or travel operator who has purchased seats on the charter flight; or
- (c) tour conductors in charge of and conducting a group of not less than fifteen persons travelling on the charter flight.

Submission of Substitute List to Authority

23. (1) The operator of a charter flight shall within not less than thirty days before the date of the charter flight submit to the Authority a Substitute List as set out in Form Four of the Third Schedule where the circumstances specified in subregulation (2) exist.

(2) A tour or travel operator who has sold a seat on a charter flight to a passenger may, subject to subregulation (3), resell the seat of that passenger to a substitute passenger, where the passenger to whom the seat was initially sold could not for a good reason be carried on that charter flight.

(3) The number of seats which the tour or travel operator may resell to substitute passengers shall not exceed fifteen percent of the total number of seats on the charter flight, purchased by the tour or travel operator from the operator of the charter flight. Entry of persons on Waiting List in Substitute List

24. (1) The operator of a charter flight shall enter in the Substitute List only the names of persons entered in the Waiting List compiled by the tour or travel operator or the name of the child of the person who was on the Waiting List and who has given birth after the Waiting List has been compiled.

(2) The tour or travel operator shall close the Waiting List at least sixty days before the date of the proposed charter flight and shall submit to the Authority on request, a certified copy of the Waiting List.

(3) The Waiting List is as set out in Form Five of the Third Schedule.

Submission of Notice of Consolidation

25. Where the operator of a charter flight intends to carry on a charter flight and a person whose name is entered in the Advance List of a previous scheduled charter flight which had been cancelled is added to the Advance List, the operator of the charter flight shall within not less than thirty days before the date of the proposed charter flight submit to the Authority, a Notice of Consolidation as set out in Form Six of the Third Schedule.

Submission of post flight list

26. (1) The operator of a charter flight shall submit to the Authority within fifteen days after a request has been made by the Authority, the post flight list as set out in Form Seven of the Third Schedule.

(2) Subject to regulation 22, a person shall not be carried on a charter flight by the operator of a charter flight unless

(a) the seat of the person on the charter flight has been sold to that person by the tour or travel operator specified in the Advance List for that flight or for the cancelled charter flight specified in the Notice of Consolidation referred to in regulation 25;

(b) the seats of the person travelling on both outward and return journeys have been allocated to that person by the same tour or travel operator;

(c) before the outward journey of the person began, that person was provided with one ticket for a round trip which entitles that person to be carried on both the outward and return journeys but not to be carried on a return journey within less than fourteen days;

(d) the ticket issued to that person bears the name of the tour or travel operator who resold the seat on the charter flight to that person and the amount paid by that person for the outward and return journeys; and

(e) the name of the person appears in the Advance List for that charter flight or for the cancelled charter flight specified in the Notice of Consolidation.

(3) Subregulation (2) does not prevent the operator of a charter flight from carrying

(a) the child of a person named in the Advance List of a charter flight who is born after the list was submitted to the Authority;

- (b) a person referred to in subregulation (2) of regulation 21 or subregulation (4) of regulation 24 whose name and particulars have been submitted to the Authority before the date of the proposed charter flight.
- (4) Despite paragraph (b) of subregulation (3), not more than
 - (a) ten of the persons referred to in paragraph (b) of subregulation (4) of regulation 22 may be carried on a charter flight; and
 - (b) one of the persons referred to in paragraph (c) of subregulation (4) of regulation 22 may be carried on a charter flight for each fifteen members of a group.

Emergency cases

27. (1) Where as a result of an emergency a passenger is unable to travel on the charter flight which the ticket of that person entitles that person to be carried on, the operator of the charter flight shall notify the Authority of the intention of the operator of the charter flight to carry a substitute passenger.

(2) Where the Authority is satisfied that an emergency exists, the operator of a charter flight may carry a substitute passenger on the charter flight despite the fact that regulation 25 has not been complied with by the person who operates the charter flight.

Miscellaneous Provisions

Interpretation

- 28. In these Regulations, unless the context otherwise requires,
 - "Advance Booking Charter Flight" means a charter flight operated in accordance with these Regulations;
 - "operator of a charter flight" means a person responsible for the management of an aircraft and who holds a licence to operate a charter flight issued under these Regulations;
 - "prescribed fee" means a fee prescribed in the Fees and Charge (Miscellaneous Provisions) Act, 2018 (Act 983);
 - "tour" includes a conveyance of persons by land, sea, or air for the purposes of tourism, whether inbound or outbound,

"tour or travel operator" means a person who holds a tour or travel operator's licence issued under these Regulations authorizing that person to make available accommodation for the carriage of passengers on an Advance Booking Charter flight or a person outside Ghana who makes available accommodation for the carriage passengers on flights in circumstances that would require that person, if in Ghana, and if not exempted by the Authority, to hold that licence; and

"travel operator" includes a travel agency;

"travel trade enterprise" includes

- (a) a tour operator;
- (b) a travel agency;
- (c) a car rental operator;
- (d) a tour guide;
- (e) a charter flight operator; and
- (f) a site guide.

Revocation and savings

29. (1) The following Regulations are revoked:

- (a) Charter Flights and Tours Regulations, 1972 (L.I. 762); and
- (b) Tour Operators (Registration and Licensing) Regulations, 1983 (L.I. 1293).

(2) Despite the revocations under subregulation (1), any bye-laws, notices, orders, directions, appointments or other acts lawfully made or done under the revoked enactments and in force immediately before the commencement of these Regulations shall continue to have effect as if made under these Regulations with the necessary modifications until amended, revoked, cancelled, withdrawn or terminated under these Regulations.

Transitional provisions

30. On the commencement of these Regulations, a person who is registered or holds a licence under any of the revoked enactments is deemed to have been registered or licensed under these Regulations subject to necessary modifications to bring the registration or licence in conformity with these Regulations.
